



MEMORANDUM OF UNDERSTANDING

between

National Yunlin University of Science and Technology (Yunlin, Taiwan)

and

Kobe City College of Technology (Kobe, Japan)

National Yunlin University of Science and Technology (YUNTECH), located at 123, University Road, Section 3, Douliou, Yunlin 64002, Taiwan, and Kobe City College of Technology, located at 8-3, Gakuen-Higashimachi, Nishi Ward, Kobe City, Hyogo 651-2102, wishing to develop academic and cultural interchange between the two institutions in education, research and other areas, agree to formally establish a collaborative relationship with each other. Subject to mutual consent, the provisions of the agreement are as follows:

Article I.

The areas of collaboration include any program offered by either organization in which the two institutions believe collaboration is feasible and desirable and which would develop and enhance a mutually beneficial relationship between the two organizations.

Article II.

Subject to the approval of the President of each institution and the availability of funding, assistance shall be carried out through any one or more of the following activities or programs as mutually agreed to by both parties.

- i.** Student Study at INTENSE Program and GRADUATE Program
- ii.** Student Exchange Program
- iii.** Faculty Exchange Program
- iv.** Special Short-term Academic Programs
- v.** Staff Development Projects
- vi.** Joint Research and Activities

Supplementary Terms:

- i.** Based on the long-term partnership between both parties, the Kobe City College of Technology shall recommend three guaranteed admission slots for Japanese students to National Yunlin University of Science and Technology before November each year.

National Yunlin University of Science and Technology shall issue pre-admission notices to the recommended students by December.

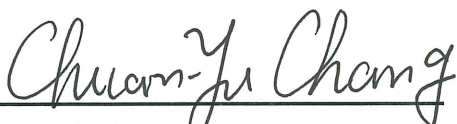
- ii. Recommended students must complete the online application process and submit all required documents (including proof of Chinese language proficiency at A2 level or above) between February and April of the following year, in accordance with the university's relevant regulations and schedule. This is to facilitate the review process at National Yunlin University of Science and Technology and to issue formal admission notices, ensuring the students can enroll smoothly in September of the same year.
- iii. If the recommended students fail to complete the application procedures or submit the necessary documents as stipulated, resulting in not passing the review or failing to enroll successfully, the responsibility shall be borne by the recommended students themselves.

Article III.

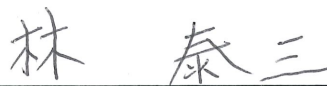
This general memorandum shall be effective upon signature by two parties and shall remain in force for a period of five years. Thereafter, unless either institution provides written notice of amendment or termination at least six months prior to the expiration of the effective period, it shall be automatically renewed on an annual basis.

Article IV.

Any amendment to this MOU shall be based on the mutual consent and requires the written approval of the President of each institution that shall be appended hereto. This declaration will become effective with the agreement of both parties.
