

MEMORANDUM OF UNDERSTANDING

This agreement is made between

De Montfort University (the University)

and

National Yunlin University of Science & Technology (the Institution)

in order to declare their joint intention to co-operate in some or all of the fields of academic endeavour to their joint benefit.

The University and the Institution (the Partners) agree to explore opportunities for collaboration in the areas of activity described hereunder: -

- student exchange
- staff exchange and staff visits
- collaboration in the provision of programmes or parts of programmes of study
- collaboration in the provision of programmes offered jointly with the University and leading to awards of the University or of External Agencies which have delegated authority to the University for awards.
- recognition of equivalence and/or accreditation of the awards of the Institution
- academic subject development
- development of teaching and learning strategies or materials
- collaborative research activities
- collaborative consultancy

The University and the Institution (the Partners) agree to share information in strict confidence and will respect the intellectual property rights of each other.

In the event that the decision is not to pursue a collaborative activity, all information will be returned to the rightful owner.

Permission to deliver a collaborative activity must receive detailed approval by both Partners prior to a formal agreement laid down by a Memorandum of Co-operation duly signed by the Vice Chancellor of the University and the Chief Executive of the Institution (or their nominee).

Specific agreements will be made from time to time concerning particular collaborative activities. Such agreements will take the form of Annexes to the Memorandum of Co-operation and will require the signature of the Vice Chancellor of the University and the Chief Executive of the Institution (or their nominee).
